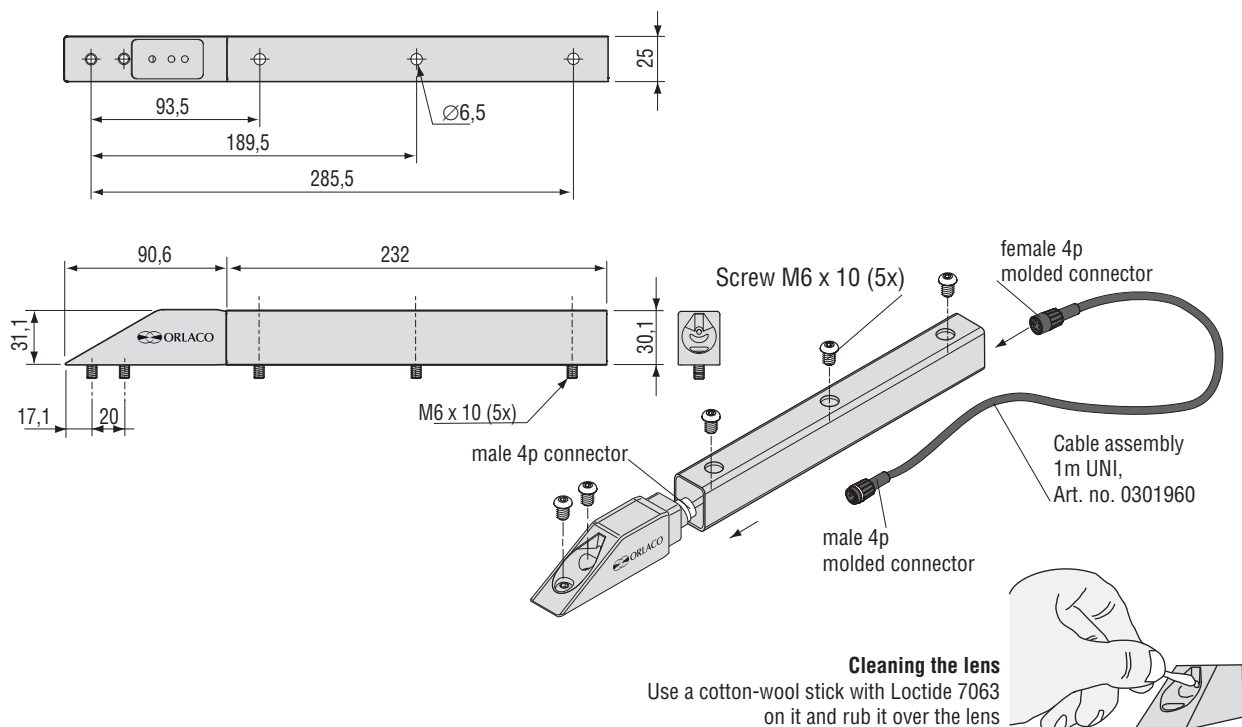

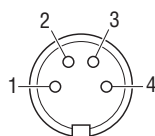

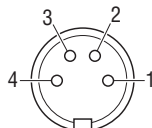


Front Side Molded

Installation

Install the camera between the forks on the right side.

General practice in the forklift industry allows mounting on forks as long as the following rules are fulfilled:

- Only screw connections are allowed.
- Maximum thread is M6.
- Maximum drilling depth is 10 mm.
- Distance between the fork heel and the hole has to be more than 20% of fork length.
- Drilling has to be in the centre-line of the fork.

Orlaco is never liable for any damage of the forks or damage caused by malfunctioning forks for installations without the formal permission of the fork manufacturer.

IMPORTANT!: Any drilling in the fork must be first formally approved by the appropriate fork manufacturer.
